Today in the limelight





On February 16th, 2016 Quatrefolic®, the biologically active form of the naturally-occurring predominant form of folate, has been approved as food additive by the Ministry of Health of the People's Republic of China (MOH).

In the next months Quatrefolic® will be officially listed in the regulation GB 2760-2011-NATIONAL STANDARD OF FOOD SECURITY: Usage Standard of Food Additives, in the category related to Instant Drinks preparation.
